Semi-detached dwelling in need of refurbishment with a side garden suitable for a new dwelling, subject to planning





## 105 Hadlow Road, Tonbridge, Kent, TN9 1QE

An opportunity to purchase a 3-bedroom semi-detached property in need of refurbishment with scope for a new dwelling within the side garden subject to obtaining all the necessary consents.

#### The Site

The total site area is 0.09 hectares. Built in the 1950's as a pair of semi-detached 'Police Houses' 105 Hadlow Road is now vacant and surplus to the requirements of the NHS.

#### Location

The site is conveniently located for Tonbridge town centre and a number of local schools. Access is off the A26 with the property slightly set-back from the road.

### The Opportunity

The existing dwelling presents the opportunity to extend to the rear and perhaps utilise the roofspace for an additional bedroom. General upgrading is required to provide a contemporary

family home. To the side, there is scope to build a new dwelling of similar proportions (subject to obtaining all the necessary consents). This would require the removal of the existing side extension of 105 Hadlow Road.

#### **Planning**

The site lies within the jurisdiction of Tonbridge & Malling Borough Council. A precedent has already been set for the formation of a terrace of 3 dwellings as planning permission was granted in 2004 for a new dwelling in respect of the adjoining pair of semi's 109/111 Hadlow Road - planning application reference TM/04/02178F/L. This would represent a material planning consideration in the determination of a new dwelling within the side garden of 105 Hadlow Road.
