Unique opportunity to acquire a historic development site

Location

The site is approximately 0.5 miles from the centre of the town of Bakewell, within the Bakewell conservation area. Bakewell offers a diverse range of local facilities and employment opportunities to cater for the local residents and the high demand of tourists means there is a good range of services available.

Chesterfield is located 12.3 miles east, directly along the A619 and Sheffield is located 16.5 miles north east along the A625.

Situation

Newholme Hospital fronts onto Baslow Road (A619) which leads south into the main high street where a range of shops and services are available within walking distance (approx. 10 min walk).

Immediately surrounding the site are residential developments comprising traditional 2 storey semi - detached and detached dwellings. To the west, the site looks out onto open countryside.

Description

Newholme Hospital is understood to have initially been established as a Union Workhouse in 1841 and the freehold is owned by the NHS. The site currently operates as an NHS hospital facility, however the services are to be relocated to the new Bakewell Health Centre adjacent. The site is accessed from the A619 via two separate drives which pass a number of ancillary stone buildings, gardens and mature trees.

The site comprises of a number of separate detached buildings in a parkland setting, with the main former hospital block, currently providing administrative space, comprising a two-storey building with symmetrical front and rear wings, traditional stone elevations, gabled bay windows and pitched state roofs. Board Tudor arches to the rear provide access to a rear paved courtyard.

To the rear of the site is a more modern development, constructed post 1948, of stone construction. There are a number of car parks situated across the site, as well as multiple landscaped areas.

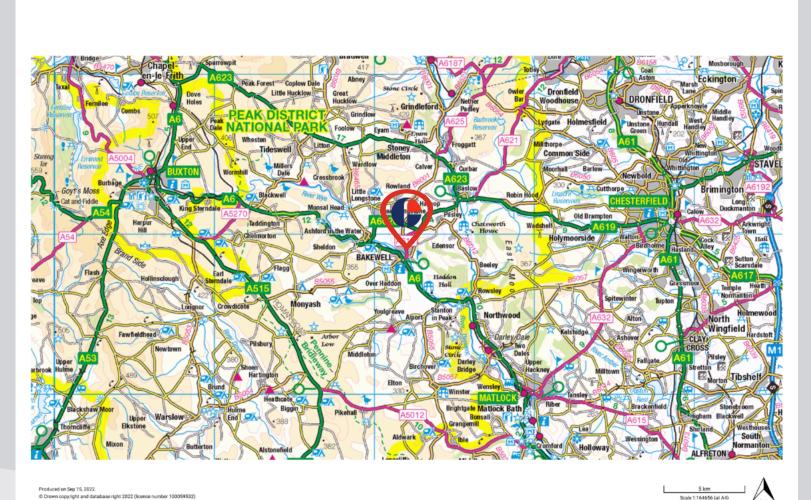
