## **Climate Adaptation Policy Statement**

- Ensuring adaptation is embedded within our corporate strategy, internal policies, and operational procedures. These include our Business Continuity Plan, Energy Policy and Environment Policy.
- Utilising both structural and green approaches to improve the adaptive capacity of the infrastructure at our facilities.
- Setting clear and well-defined short and long-term goals aimed at improving our adaptive capability.
- Advocating cultural and behavioural change of our colleagues, supply chain, stakeholders and interested parties.
- Ensuring compliance with relevant legal obligations and keeping up with new and updated policies on climate change.
- Utilising applicable standards and frameworks within the delivery of our initiative.
- Providing relevant information, instruction, and training to our colleagues to enable competent understanding of climate-related subjects.
- Widening adaptation capability beyond NHSPS by building resilience along our value and supply chain

We will also plan stages to review its effectiveness as well as making sure actions with high cost and long-lead times are sufficiently monitored and progressed.
